Undersigned agrees to indemnify, hold harmless, COLORADO WEAPONS TRAINING LLC, it's officers, instructors, employees, and contractors, (hereinafter referred to as "Sponsor") from any and all fault, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with the undersigned's presence at and/or participation in the course of instruction; discharge of firearms by Undersigned; Undersigned's presence on or use of the range, buildings, land and premises ("Premises");
